## Insurance Waiver/Release Form

I \_\_\_\_\_ willingly agree to the following statement as participant in the *Sea to Sea 2008 West Michigan Ride-Along* offered through Volunteers In Service in conjunction with *Sea to Sea 2008 bike tour* on August 16, 2008.

In consideration of being allowed to participate in the *Sea to Sea 2008 West Michigan Ride-Along*, an event sponsored by Volunteers In Service in conjunction with *Sea to Sea 2008 bike tour* and in consideration of the benefits to be derived therefore, I hereby release Volunteers In Service and *Sea to Sea 2008*, and its present and former trustee, officers, directors, employees, agents and their heirs, administrators, executors, successors and assigns from all claims and liabilities of any kind, whether known or unknown, which arise from or are connected in any way with my participation in the trip.

I recognize that the conditions in some of the places to which I will travel are not of the same standard as the conditions to which I am accustomed. I realize further that there are certain health risks as well as other risks I will be exposed to while participating in this event. I fully acknowledge those risks and agree to follow safety requirements including the use of a bike helmet.

In the event of an emergency, I hereby authorize a leader of this activity, as an agent for me, to consent to: any x-ray examination; medical, dental or surgical diagnosis; treatments; hospital care advised and supervised by a physician, surgeon or dentist (as appropriate) licensed to practice under the laws of the state or country where services are rendered, either at a doctor's office or in a hospital. I expect my emergency contact will be contacted as soon as possible. I acknowledge that I have adequate health insurance to cover me while on this ride and I will provide documentation of this as requested.

I understand that this document constitutes as a full and complete waiver of all possible claims for any act or omission, including claims for negligence regarding injury or property damage arising out of my participation in the ride.

I understand that this release applies to, covers and includes unknown, unforeseen, unanticipated, and unsuspected damages, losses or liabilities and the consequences thereof, which result from the matters herein before inferred to as well as those now disclosed and known to exist. The provisions of any state, federal, local, provincial or territorial law or statute providing in substance that releases shall not extend to claims or damages which are unknown or unsuspected to exist at the time are hereby expressly waived by me.
