Wednesday, March 1, 2023

Article 98-1 Anthony Selvaggio, chair for this session, called the meeting to order. Credentials were presented, first-time delegates (Diane Tiwow, Rose Hiskes, Dexter Green, Sue Bratt-Cok) signed the Covenant for Officebearers, and delegates and guests were

Article 98-3 A time of worship and singing was led by Sam Sutter, Matthew Burns and Will Barham. Dan Wolters led devotions based on Deuteronomy 6:4-9, reminding us that we are all disciple makers, called to help people move in the direction of loving God and following

Jesus Christ. The Deuteronomy passage was a reminder to God's people of who they really were, who they were meant to be. We are also called to remember that as a classis, too, and to know our calling is to invite people to love God more and more wholeheartedly.

Article 98-4 The chair appointed the following pro-tem committees for this meeting:

Article 98-5 Treasurer's report

- Classis Treasurer Thalia Towle reviewed the financial reports that were sent out ahead of the meeting. FY 2022 ended well; classis accounts are healthy, as are our investments, though they also were affected by a poor economy in the past year.
- 5.2 Thalia thanked the churches of classis for sending in their ministry shares.
- Paramus Fund: Thalia reported that four grants were awarded this past year; more money is still available.
- 5.5 The VEMACONY Fund still has money available for helping with youth projects.
- 5.6 Classis has also been able to help some of our emerging churches with some small grants as well.
- 5.7 A motion to approve the work of the Treasurer was supported and **APPROVED.**

Article 98-6 Stated Clerk's report

- 6.1 Classis Stated Clerk Dave Poolman briefly reviewed the report he e-mailed with the agenda for classis. He thanks classis for its understanding in light of the damage to the facility where we meet and adjustments that had to be made regarding overnight accommodations. He briefly mentioned his experience at the Stated Clerks' Conference in California in January.
- 6.2 A motion to approve the work of the Stated Clerk was supported and **APPROVED.**

Article 98-7 Classis Interim Team (CIT)

- 7.1 Michael Saville highlighted the CIT report. A written report was sent to the pastors and churches of classis prior to this meeting; a copy of the report is filed with the minutes of this meeting.
- 7.2 CIT has sought to provide support to the three oversight committees currently functioning in classis.
- 7.3 Classis personnel appointments
 - 7.3.1 Michael Saville is now chair of CIT. The previous chair, Joel VandeWerken, continues to serve on CIT.
 - 7.3.2 Open positions still remain for Disability Concerns Advocate, Leadership Development Team (two people), Church Multiplication Team (one person), Church Renewal Team (one person).
- 7.4 Pulpit supply for vacant churches
 - 7.4.1 The River (Douglas, MA) requests continued pulpit supply on the third Sunday of each month.
 - 7.4.2 Trinity (Richfield Springs, NY) no pulpit supply is requested.

- 7.4.3 Immanuel (Wappingers Falls, NY) requests periodic pulpit supply.
- 7.5 Incorporation of Classis Atlantic Northeast: Henry Lane reported that the required paperwork for the Commonwealth of Massachusetts is complete and has been filed. CIT is also in the process of revieing the classis by-laws.
- 7.6 Church Order Article 12-c approval of Rev. Nick Monsma to be Campus Pastor at East Palmyra Christian School Michael Saville provided some of the history and background to this request; Nick spoke about his role at the school, the growth the school has been experiencing in recent years, and his desire to help the school become a discipling community. There is a need for Nick's position because there are a lot of new families associated with the school who do not come from churches that are confessionally reformed. Nick answered some questions. Classis was reminded that CIT has already approved this, but it requires the approval of classis and the synodical deputies. A motion declaring that this position is consistent with the calling of a minister of the Word was supported and **APPROVED**. The Synodical deputies **CONCURRED**.
- 7.7 Joel Gagnon sustained an examination for Commissioned Pastor at our October 2022 meeting. At that time classis also required Joel to have a psychological exam completed before being ordained as a Commissioned Pastor. CIT was informed on February 15 that a psychological evaluation has been completed by a licensed psychologist, and notes that all requirements for ordination have now been fulfilled. Classis authorized the church counselor (Ryan Goding) to work with the River of Life council to proceed with Joel's ordination.
- 7.7 Information for first-time delegates a handout called Welcome to CANE has been prepared and will be sent out with each meeting's agenda. The handout is designed to inform first-time delegates about classis and how it works, how it is structured, the various teams that report, etc.
- 7.8 CIT also worked with the Stated Clerk to set the agenda and make other arrangements for the March 2023 classis meeting.

Article 98-8 Church Renewal Team (CRT)

- 8.1 Sam Sutter read 1 Corinthians 15:58—"Therefore, my dear brothers and sisters, stand firm. Let nothing move you. Always give yourselves fully to the work of the Lord, because you know that your labor in the Lord is not in vain"—and spoke of how church leaders run the risk of not standing firm. It is possible for us to be distracted or discouraged by circumstances and tempted to believe that our work counts for little or nothing and we should give up. CRT's goal is to help churches become and stay healthy. Its best work is done proactively, before things fall apart. CRT invests some of the money of classis in things that matter through Paramus Fund (new outreach events), providing church project loans to help churches become more healthy, and through VEMACONY funds for helping youth ministries. Sam encouraged churches and pastors to reach out to CRT and to our regional pastors to talk, help with problems, etc.
- 8.2 Safe Church: Jodi Koeman no report
- 8.3 Sam Sutter will be stepping down as chair of CRT; Nick Monsma has agreed to become the new chair. A motion to thank Sam for his work and approve Nick as the new CRT chair, effective July 1, was supported and **APPROVED**.

8.4 Counselors of vacant churches reports

- 8.4.1 The River (Douglas, MA): Dave Poolman reported that attendance has remained fairly stable, giving is good, and The River is receiving additional income from a local child care that rents space from the church. They request continued classis pulpit supply on the third Sunday of each month.
- 8.4.2 Trinity (Richfield Springs, NY): Sam Sutter reported that attendance at Trinity has been relatively static for years and remains so. Classis noted the faithful service of Harold and Carrie Philbrook and the fact that Carrie's health is a concern; prayer was offered for the Philbrooks and the ministry at Trinity.
- 8.4.3 Immanuel (Wappingers Falls, NY): Sam Sutter reported that Immanuel is doing well with pulpit supply. Two calls have been declined, so their pastor search team is starting over. They are experiencing some stresses associated with transition and vacancy, but the leadership wants to strengthen ties between Immanuel and other churches in classis. They also appreciate Sam's work with them.
- 8.4.4 River of Life (Athens, ME): Ryan Goding reported that Joel Gagnon's ordination has been pending while his psychological evaluation was in process, but now that is complete and they are ready to move forward. Ryan also noted Joel has a good support system around him.
- 8.4.5 Community (Baldwinsville, NY): Nick Monsma reported that he is in contact with them and will have an additional report at our October meeting.

8.5 Church Visitor reports

- 8.5.1 Pleasant Street (Whitinsville, MA): Mike Laird and Dave Poolman Mike and Dave visited with Pastor Matthew Burns and several representatives of the council on December 1, 2022. They reported that things are much calmer at Pleasant Street and they feel that ministry there is being done with a good and positive spirit.
- 8.5.2 New Hope (Bangor, ME): Joel VandeWerken and Michael Saville Michael reported that he and Joel had a Zoom meeting to talk about New Hope's financial situation and needs. Classis will consider this further when we get to matters from their credentials.
- 8.5.3 River of Life (Athens, ME): Matthew Burns and Joel VandeWerken no report.

8.6 Oversight Team reports

- 8.6.1 Annika Bangma: Brent Averill, Joel VandeWerken, and Ann Roon Brent reported that Annika and her family are now attending and active at The River; Annika is helping where she can. From a classis standpoint, this matter is complete. Classis thanked the oversight team for their work.
- 8.6.2 Jonathan Fischer: Tim Curtis, Mike Sullivan, Chris Fluit and Katie Watts

 Classis moved into executive session for this discussion. (Note: Confidential detailed minutes of this session are included in a separate file with the minutes of Meeting #97 of Classis Atlantic Northeast) Mike Sullivan noted that Jonathan has indicated that he is resigning from ministry in the CRC and does not plan to return to the denomination;

- he plans to enter a non-ministerial job. A motion to honorably release Jonathan Fischer from the ministry of the Word in the CRCNA (Church Order Article 14-c) was supported, discussed and **APPROVED**. The Synodical deputies **CONCURRED**. From a classis standpoint, this matter is complete. Classis thanked the oversight team for their work and voted to end executive session.
- 8.6.3 New Hope (Bangor, ME): Bill Johnson, Jodi Koeman, Ryan Goding, and Nick Monsma Ryan Goding reported that the team has been anticipating the appointment of a Specialized Transitional Minister (STM). Roger Sparks has now arrived in Bangor to take on that role. New Hope has also developed and implemented a Safe Church policy as directed by classis. It is anticipated that the oversight team will remain in place until the time comes to make a recommendation to classis about New Hope's readiness to extend a call (Church Order Article 17-a, supplement, b.4).

Article 98-9 Church Multiplication Team (CMT)

- 9.1 Mike Sullivan reported on the CMT's mandate to work with new or young churches and church planters in classis. They are also looking for emerging missional activity in New England in a time of spiritual dryness.
- 9.2 The Indonesian CRC's first official service as an organized church was held on October 30, 2022. Michael Lapian's ministerial credentials have been processed by Valley and the CIT and have been sent to the Indonesian Church.
- 9.3 Chin Christian Church of Syracuse: Michael Saville reported that he will be visiting with them on March 12, 2023. Brent Averill introduced three members of the Chin Christian Church who were present: Pastor David Lian, his wife Emilia Sin, and Elder Za Hu; Emilia and Za both spoke briefly. Pastor David and Emilia have been in Syracuse for about three years; they hope that eventually David will become a Commissioned Pastor. Their congregation meets in an RCA church in Syracuse. We look forward to deepening ministry and relationships with the church. Brent Averill prayed for God to bless and use them.
- 9.4 Church plant updates (oral reports; written report in the fall)
 - Emmaus City (Worcester, MA; calling church is Pleasant Street): Mike Sullivan reported that Jesus is steadfast and His people are steadfast. They have started doing Sunday School with five other churches of varying denominations. They have faced some tough situations, but the whole church is sharing the load (not just Mike as pastor). Mike has also been starting some ministry in the prisons in Shirley, MA, where Trevorous Weaver serves as a chaplain and has been building a church in the prison there. Mike asked that we continue to pray for Emmaus City, especially at 9:38 each morning and evening, pleading with the Lord to send more workers into the harvest fields. Find out more about what's going on at **Emmaus** City at jesuslovesworcester.com.
 - 9.4.2 Resurrection CRC (East Boston, MA; calling church is The River): Justin Ruddy reported that "things are lovely" there right now. God is good and doing surprising things and answering prayers. They are now 4

years old and have a core of 80 people. They sense a real vibrancy in their community right now. The core group there was 85% white, 15% Asian American when they started, but have prayed that their demographics would increasingly reflect the neighborhood. Today they are 50% non-white, and growing especially in Latino and Spanishspeaking attendance. Worship services and communication is now done in English and Spanish. Justin asked that they pray for protection, preservation and expansion in the neighborhood/community. Find out about what's on at Resurrection more going https://www.resurrectionbos.org.

- 9.4.3 The Neighborhood (Providence, RI; calling church is The River): Joe and Karisa Paravisini reported that The Neighborhood is made up of several intentionally-small home-based church communities that are linked together. Joe still working bivocationally and but also developing a home-based business. Their immediate family is doing well, but Joe's father had a stroke and is also in an advanced stage of Alzheimer's. They have been working with some seekers and seeing some of them, including one "hard core atheist," move toward faith; they are looking forward to several baptisms this summer including at least one adult baptism. Joe and Karisa asked that we keep praying for their church, family, and also people connected to The Neighborhood who are struggling with alcohol abuse. - Spring Rain (Malden, MA; calling church is Avery Street): Polo Kim 9.4.4 reported that their infant son Habakkuk is doing well in spite of some worries during pregnancy. His wife Dandan and their older son Micah are also doing well. He thanked classis for being part of the journey with him. He reported that their previous intern had to return to Germany because of visa issues, but they have a new from Malaysia who is very gifted for ministry. A new leadership team of five people is in place; they will have a retreat next week to reconsider and own the vision for multicultural ministry. They have launched new Family Groups to emphasize community relationships in the church and have also resumed Friday evening prayers. They are thrilled about a new convert, an Indonesian man who is the first convert at Spring Rain. They have experienced some spiritual warfare as well, but remain alert to the spiritual battles going on. They are also trying to learn how to minister to a homeless woman who has been coming to the mission house; she is clearly mentally ill and in spiritual bondage—they are learning to love her and find ways to bring her to Jesus. They are also large enough that they are looking for a bigger space because the house is no longer large enough. Polo asked for the prayers of classis for them.
- 9.4.5 Iglesia Hispana (Goshen, NY): Gilbert Varela spoke of how the church has been a blessing to him, noting that he expected things to happen little by little, but they have been happening more quickly and all at once. They started with 5 people, kept praying, and people started showing up. They started worship services last Easter and 35 people

came. They have witnessed tremendous blessings: baptisms, new members, and another group waiting to be baptized. They are focusing on developing their ability to reach into their community, develop leaders, and connect with each other. Gilbert also mentioned that his father passed away three weeks ago, which has been very tough on him. More information is available from Gilbert at gvarelas2000@gmail.com.

9.4.6 Classis closed this session with corporate prayers for our church plants and their pastors and their families.

Thursday, March 2, 2022

Article 98-10

A time of devotions was led by Matthew Burns. He read Psalm 113, a morning psalm, in English, and then asked Marco Avila to read it in Spanish and Deibi Lapian to read it in Indonesian. Matthew then read a prayer from Neil Plantinga's book *Morning and Evening Prayers*.

Article 98-11 Leadership Development Team (LDT)

- Justin Ruddy reported that LDT continues to need some new members to help spread the load of their work. He worked with CIT and Joel Gagnon to complete the requirements for Joel's pending ordination as a Commissioned Pastor, and also communicated with a couple of other churches about processes for leaders in training. He communicated with the classis treasurer regarding student fund allocations and maintained contact with the three leaders we are supporting: Josiah Chapman, Peter Cho, and Blake Phillips.
- Josiah Chapman introduced himself and gave some background information as he works toward chaplaincy in the U.S. Army. He is a chaplain candidate in the Maine Army National Guard, and is also working through the EPMC program at Calvin and on an online MDiv degree from Liberty University.
- Justin welcomed Bethany Miller. She is receiving encouragement and help from Rochester CRC to move forward with obtaining a license to exhort. Classis anticipates that we will do a licensure exam with Bethany at our October 2023 meeting.
- Lorraine Li was also invited to introduced herself. She is a graduate of Calvin Seminary, who went to China with Resonate after graduation. She and her husband returned to the States in 2014. She is a member of Church of the Servant in Grand Rapids, MI, and a Commissioned Pastor in Classis Grand Rapids East, but is interested in becoming a Commissioned Pastor in CANE because she is now working at First United Presbyterian Church in Cambridge, MA. Her husband, a former professor, is now ordained in the PCUSA. They have a small house church that meets on Fridays for a meal and study of the Heidelberg Catechism. She asked classis to pray for God's guidance for their future and how we can work together. The CIT was tasked to work with Lorraine to figure out mechanics of how to make this work and explore ideas for shared ministry.
- Justin Ruddy will be stepping down as chair of LDT; Matthew Burns has agreed to become the new chair. A motion to thank Justin for his work and approve Matthew as the new LDT chair, effective immediately, was supported and ADOPTED.

Article 98-12 Denominational and Synodical matters

- Election of delegates to Synod 2023 (June 9-15 at Calvin University in Grand Rapids, MI) After discussion and voting, the following were elected as delegates to this year's synod:
 - Minister delegate: Matthew Burns (Pleasant Street CRC)
 - Elder delegate: Clyde Williams (Webster CRC)
 - Deacon delegate: TBD
 - At-large delegate: Will Barham (Webster CRC)
 - Minister alternate: Michael Saville (East Palmyra CRC)
 - Elder alternate: TBD
 - Deacon alternate: TBD
 - At-large alternate: Joel VandeWerken (Fairlawn CRC)
- 12.2 Since we have only one Elder delegate and no Deacon delegates, the pastors in classis were asked to go back to their councils and seek nominees for the open positions above. Names of nominees are due to either Michael Saville or Dave Poolman no later than March 15.
- 12.3 Elections for denominational boards and committees: No nominations or elections for denominational boards or committees are required at this time.

Article 98-13 Denominational Ministry reports

- 13.1 CRCNA Council of Delegates (COD): Anthony Selvaggio reported on his experiences at the last COD meeting. Discussions included looking at membership trends and metrics, confessional exceptions, and the proposed Code of Conduct for ministry leaders which is being sent to Synod 2023 for approval.
- 13.2 Calvin University: Wayne Coleman no report.
- 13.3 Calvin Theological Seminary: Kris Vos no report.
- Resonate Global Mission: Marco Avila explained some changes going on in 13.4 leadership of Resonate since Zachary King became general secretary of the CRCNA. Resonate works on church planting and global ministry, including 16 new church plants. Active church planters will be meeting together in June in New Jersey; representatives of SEAPI churches also met together last year to pray, get to know each other, talk about working together, etc. Resonate also has a new full-time person to start Haitian church in Florida, as our ministry to Latinos is also growing very quickly. Diane Averill added comments about Coffee Break, the recent women's weekend retreat at Camp CONNRI where they had to turn people away because there wasn't enough room for everyone who wanted to come. Lots of new material is now available for Coffee Break. Diane also reported for the Connections Team and reminded delegates that Deibi Lapian helps out with SEAPI churches. Diane and Deibi passed out a "playlist" of resources that are available (this list will be attached to the minutes of this meeting when they are sent out). Marco also thanked the churches of classis for their ministry share contributions.
- 13.5 World Renew: Emily Boldenow Fortna (a World Renew report dated January 2023 was distributed prior to this meeting) Emily introduced herself to classis; she is our new board representative. She shared a story from a trip to El

Salvador that illustrated the kinds of work and transformation World Renew gets involved in. She reviewed some of the current projects in Florida and Ukraine, as well as a response to the earthquakes in Turkey and Syria through local partners in those countries. She also briefly explained what Free a Family (mentioned on the report) is all about.

Article 98-14 Other matters and reports

- 14.1 Credentials committee The delegates from Pleasant Street reported that the credentials provided for this meeting were in order, and noted the following:
 - 14.1.1 The council of New Hope CRC (Bangor, ME) moved "that classis provide \$5,000 of revitalization funds to New Hope Church to help offset the salary of a Specialized Transitional Minister (STM)." The motion was supported. Grounds for this one-time request were presented and are found on a separate document filed with the minutes of this meeting. Discussion ensued about where to find the funding and setting a precedent. Ultimately classis decided to use money from the general fund of classis to meet this need. After discussion, the motion was APPROVED, and our classis treasurer, Thalia Towle, was authorized to arrange for payment.
 - 14.1.2 The council of New Hope CRC (Bangor, ME) requested "that classis create provision for revitalization funds going forward by establishing a line time for CRT revitalization requests in next year's CANE budget, grant CRT the authority to review requests for revitalization efforts within CANE and grant funds when appropriate, and provide CRT guidance on how to evaluate revitalization requests." Grounds for this request were presented and are found on a separate document filed with the minutes of this meeting. A motion to refer this matter to CIT to discuss and bring a recommendation to the October 2023 meeting of classis was supported and **APPROVED**.
 - 14.1.3 The council of Immanuel CRC (Wappingers Falls, NY) requested the assistance of classis with periodic pulpit supply. This was received for information; CIT is already working with Immanuel on this.
 - 14.1.4 The council of Immanuel CRC (Wappingers Falls, NY) requested that classis discuss its "view on the grassroots movement for reformation in the CRCNA." Discussion identified this "grassroots movement" as associated with the "Messy Reformation" podcast, which aims to promote reformation and a return to biblical faithfulness and reformed theology. Michael Saville (mrsaville@gmail.com) can be contacted for more information.
 - 14.1.5 The council of Immanuel CRC (Wappingers Falls, NY) recommended that "Elder Gary Nagelhout pursue becoming licensed to preach." This matter was referred to LDT for their assistance and guidance.
 - 14.1.6 The council of Fairlawn CRC (Whitinsville, MA) communicated that "we are concerned about the unity of the CRC in response to some conversations apparently happening in various parts of the CRC since Synod's 2022 decisions about human sexuality. We discussed a potential communication to synod written by our pastor, but because it is not yet clear what overtures or communications may come to synod this year,

we felt it was premature to set before classis a document which might only complicate these sensitive conversations. We wonder whether other congregations have similar concerns, and how we might best respond as churches and as a classis to these discussions as they may be proposed for the synod agenda or in other settings within the CRC." Dick VandenBerg from Fairlawn's council spoke about what went into this communication. The communication referenced above is not before classis, but the concerns behind the document are pertinent to the discussion going on from different groups in the denomination. Anyone interested in seeing the document can request it from Joel VandeWerken (<u>ivwerko6@gmail.com</u>). A potential Zoom meeting to discuss these issues could be held in the future, inviting interested people in classis to join; this might help some of us respond intelligently to the issues in the day. Justin Ruddy pointed out two additional resources that can help congregations talk about these matters; they include The Challenging Conversations Toolkit available from Pastor-Church Relations (https://www.crcna.org/pcr/churches/challengingconversations-toolkit) and also the Human Sexuality Report & Synod FAQ (https://www.crcna.org/synod/hsr-faq).

This initiative is currently in the research and development stage with hopes to deliver educational opportunities to residents beginning in the fall of 2024.

1. PRAYERFUL DEPENDENCE ON GOD

- **1.1 Welcome & Opening Devotions:** The chair, Rev. Woodrow Dixon, opened the meeting with a reading of the Pentecost story from The Jesus Storybook Bible and offered prayer.
- **1.2** Roll Call and Report of the Credentials Committee: Elder Henry DeKlerk of Smithville CRC presented the Roll Call on behalf of the Credentials Committee.

1.3 Constitution of Classis: The chair, Rev. Woodrow Dixon, read the *Niagara Declaration of Agreement* with the Beliefs of the Christian Reformed Church in North America, after which delegates rose to indicate their affirmation. Classis was declared constituted.

2. COVENANTAL RELATIONSHIPS

Encouraging God's people to engage in the various relationships and activities of the church with accountability so that our institutional and relational obligations are met.

2.1 Classis Ministry Council report – CMC Chair, Rev. Erick Schuringa, drew attention to the motions that arose from the CMC meeting of March 23 regarding changes in the rotation of chairpersons and how voting for Synod will be done in future.

MOTION: Discontinue the rotation of pastors only to serve as Chairpersons and to instead invite gifted currently serving pastors, elders or deacons to chair Classis meetings: **CARRIED**

MOTION: Change how voting is done for delegates to Synod as follows: The first round of voting only selects those who will be the pastor, elder and deacon delegate. In the second round of voting all remaining pastors, elders and deacons form the slate for the 4th delegate. Alternates are then selected from those with the next highest number of votes in each category. **CARRIED**

MOTION: To approve the work of the Classis Ministry Council: CARRIED

2.2 Stated Clerk, Pulpit Supply and Classis Functionaries Report: Wendy de Jong gave a brief update on the pulpit supply list and the Functionaries report.

MOTION: To approve the work of the Stated Clerk: **CARRIED**

MOTION: To approve these nominations as per the Functionaries report: **CARRIED**

- **ANNUAL GENERAL MEETING:** Rev. Woodrow Dixon relinquished the chair at this point and CMC Chair, Rev. Erick Schuringa, led the Annual General Meeting as required by the Ontario Non-Profit Corporations Act.
 - 2.4.1 **MOTION**: To approve the minutes of the May 25, 2022 Annual General Meeting as presented: **CARRIED**.
 - 2.4.2 **MOTION**: To approve the election of Members to the Board of Directors consisting of Erick Schuringa, Chair, Frank Engelage, Vice-Chair, Karen Gerritsma, Janet Ryzebol, and Terence Schilstra. **CARRIED**
 - 2.4.3 **MOTION**: To approve the Financial Statements for 2022 as presented, and to approve the work of the Treasurer: **CARRIED**
 - 2.4.4 **MOTION:** That Classis Niagara approve the audited 2022 Financial Statements: **CARRIED**

REGULAR SESSION RESUMES

- **2.4 Council of Delegates & Canada Corp board report:** Wendy de Jong presented her final report as the Classis Niagara COD delegate, highlighting several matters covered at the May COD meeting and expressing appreciation for serving in this capacity.
- **2.5 World Renew Presentation:** Peter Bulthuis gave an update on the work of World Renew responding to disasters such as the flooding in Abbotsford last year, working with local partners to provide food and humanitarian aid in Ukraine, Turkey, Syria, and other places. Peter illustrated how the Core Humanitarian Standard that World Renew has adopted, influences their approach to come alongside affected communities, asking what is needed and how they can help, so that the aid given doesn't unintentionally harm these communities. He expressed gratitude for the financial support of \$266,000 from the churches in Classis Niagara.

3. AUTHENTIC COMMUNITY

Encouraging God's people by intentionally sharing life and story together so that classis is being transformed into a community of grace and truth.

- **3.1 Authentic Community Team Report**: Rev. Terence Schilstra introduced new team members, Devin Lunshof and Leah DeVos. As a newly formed team they met recently to pray over their mandate which is to plan annual classis retreats, encourage connections and foster community at Classis. Moving forward they will be presenting their desire to the CMC to work with other classis teams to organize a focused retreat style gathering each year.
- **3.2 Church Visitors:** Delegates were referred to the written report on a visit to Providence CRC in the agenda.
- 3.3 Church Counselor & Oversight Committee reports: Rev. Erick Schuringa gave a brief update on the work of the Oversight committee regarding Rev. Darren Roorda. Attempts at mediation were unsuccessful and they are now awaiting his decision whether he wants to pursue another call. As counsellor for Providence, Erick reported they have hired Commissioned Mike Collins to serve as an interim pastor. Rev. Steve DeBoer, counsellor for Faith Fellowship, reported they are actively engaged in a calling process. They have also made an interim arrangement with a retired Presbyterian pastor for the summer months.
- 3.4 Pastor Church Resources (PCR) Video & Discussion: Regional Pastor, Dr. Andre Basson, briefly introduced a video from Pastor Church Resources in which they presented several themes or trends they have observed that are impacting churches and pastors. Some of these are the effects of the pandemic, shifting boundaries for pastors and their families, cultural winds affecting congregations, increasing polarization and less tolerance for differences, etc. After viewing the video delegates split into small groups of pastors, elders, and deacons, to consider what they heard, how it relates to their own situation, and whether some of the resources offered might be useful for their own congregation or council to consider.

Andre closed the morning session with prayer after which delegates enjoyed a delicious meal of pulled pork on a bun and salads.

4. LEADERSHIP DEVELOPMENT

Providing opportunities to develop, equip and encourage lay and ordained leaders in every context and at every level to be on mission with God.

- **4.1 Leadership Development Team Report:** Karen Gerritsma gave an overview of what the team has been active with, naming several workshops and speakers they have arranged for Classis or local churches. They are considering their ongoing role and welcome input on the benefits of serving as a funnel or encouragement of denominational ministries or perhaps bringing in a streamlined Day of Encouragement. They are also discerning whether to refill the position of Youth Champion.
- **4.2 Classical Ministry Leadership Team:** Rev. Woodrow Dixon, Chair of the CMLT, reported that supporting the current students is on track. Only one student will be studying this summer. He also indicates a new Chair will be needed for the CMLT shortly.
- Calvin University Presentation: Tony Kamphuis, board member for Region 2 which includes Classis Niagara, gave a presentation and update on Calvin University. One new development is offering tuition for Canadian students at par with the US dollar, maintained at the amount set at the beginning of studies in an effort to reverse the steady decline of Canadians attending Calvin University. He also highlighted several other developments in sports, and their second campus at the Hanlin Correctional Institute which has contributed to significant improvements in morale at this and similar institutions.

5. DISCIPLES MAKING NEW DISCIPLES

Empowering and equipping churches and individuals to multiply ministries that will reach their local communities so that not-yet Christians may embrace Christ as Lord.

- 5.1 Disciples Making New Disciples Team Report: Rev. Janet Ryzebol pointed delegates to the ways the DMD is encouraging new outreach possibilities such as their support of Dinner Church. She also mentioned that DMD offers a fund to support new missional development initiatives. The team is very appreciative of the many years Hilda Vander Klippe has served, who is now stepping back, replaced by new members Karen Schilstra and Karina Van Lochem.
- 5.2 Brock Campus Chaplaincy Ministry Report: Rev. Zack DeBruyne was unable to report in person as he is currently attending a Christian Reformed Campus Ministers Association Retreat. Karen Gerritsma mentioned a few key items from his written report, giving thanks for the doors the Lord is opening at Brock for all kinds of ministries, including interactions with students of many different faiths, and some ideas Zack is pursuing regarding monthly worship services for emerging adults in Classis.
 5.3
 - Niagara International Students Report: Hilda VanderKlippe shared highlights from the connections being made with international students in Niagara, of whom there are between 7-8,000. They offer English language conversation circles, monthly dinners, and many social opportunities. Many of the students are extremely isolated and lonely. These social opportunities often open the door for faith conversations. Hilda asks that we join her in praying that God would grow his kingdom amidst these international students so more people groups hear the Good News of Jesus Christ.
 - **Village Church Report:** Rev. Mark De Vos introduced "Summer for the City," a new initiative underway at The Village Church. This is an internship program for young adults to spend the summer developing tangible redemptive entrepreneurship that blesses the community of Thorold. Aaron Snow, one of the interns, shared about a ministry he is currently brainstorming called "Soul Food" which provides meals for single moms in need with the hope of creating meaningful relationships and connections between the volunteers from the Village who prepare the meals, the

interns who deliver it to the door, and the families benefiting from regular meals and the hand-written letters which would accompany the meals.

- **Dinner Church Report**: Leah De Vos gave an update on this internship program. She is currently working alongside four interns, getting them acquainted with the rhythm of what Dinner Church is all about, teaching, practicing with evangelism tools, building connections, etc. so that these interns will be ready to launch their own Dinner Church at the end of the 8-month internship.
- **The Table**: Rev. Terence Schilstra shared a poignant reflection he wrote recently, reflecting on the hard season of "walking into 100 nightmares"; of the heartache and struggles experienced by people he crosses paths with and for the glimpses of seeing the kingdom of God breaking in as lives are turned around and hope for a better day is expressed.
- 5.7 Bridge Church Plant: Rev. Steve DeBoer spoke about their focus on providing a daily free breakfast to those on the margins in downtown Niagara Falls and how this focus has restored some fractured relationships with their neighbours and opened doors to a growing network of relationships with churches, other community organizations and the city. He also shared their concern about demographic changes in the neighbourhood leading them to discern whether they should pursue purchasing land and larger facilities. While breakfast doesn't change people's circumstances, Steve told how many of their guests have expressed gratitude for the way this meal and daily interaction make a difference in how they live their day.
- **5.8 Diaconal Ministries Canada Report**: Delegates watched a brief slideshow highlighting the way Diaconal Ministries Canada and New Leaf (formerly Operation Manna) contribute to lasting changes in some challenging neighbourhoods across the country.
- 5.9 Closing Prayer & Adjournment Vice-Chair, Rev. Steve DeBoer, closed the meeting with words of encouragement and gratitude for the many good things heard about and were part of together. He thanked the CMC for how they set the table at each meeting, providing meaningful learning, interaction and dialogue, and also named that while Classis was calm on the surface, there is a fair bit of anxiety for the delegates and churches regarding Synod. He thanked the chair, Rev. Woodrow Dixon, who is wrapping up his ministry at Jubilee at the end of June and offered blessings for him and thanks for his contributions to Classis. Delegates formed a circle to offer prayer, after which the meeting was adjourned.
